Subject to prior approval from the HKCITTC, and when needed, written test attendees can bring and wear their own vision-aided eyeglasses during the Wire/Cable Color Identification Test. To apply for such an arrangement, please write to the HKCITTC when you enrol for the written test.

(2) Candidates must apply for and pass the practical test within **3 years** starting from the passing day of the written test. Upon passing both the written test and the practical test, candidates will be issued a "Trade Test Certificate for Grade A Electrical Work".

(3) Candidates who fail the test are required to re-apply for the test and pay the relevant application fees. Each candidate is allowed to attempt the written test and/or practical test no more than 4 times in every calendar year (Scheduling subject to actual circumstances).

(4) Availability of these tests may be subject to interruption due to, but not limited to, equipment/facility maintenance and adverse weather conditions. - Applicants who have passed the written test (inclusive of Wire/Cable Color Identification Test) and practical test will be issued a "Trade Test Certificate for Grade A Electrical Work".
- Trade Test Certificate for Grade A Electrical Work" is not equivalent to the "Certificate of Registration of Electrical Worker" issued by the Electrical and Mechanical Services Department. For details, please visit the website of Electrical and Mechanical Services Department ([www.emsd.gov.hk](http://www.emsd.gov.hk)) or contact the Electrical and Mechanical Services Department.
- Applicants who are not Hong Kong Permanent Residents, please attach a copy of a valid working permit issued by the Hong Kong Immigration Department. The application fee is 3 times the basic testing fee for "Employment/Student Visa" holders.
- Applicants who have reached the age of 65, please call Hong Kong Construction Industry Trade Testing Centre at 2100 9000 to check which trades may require the submission of medical examination reports issued by Registered Medical Practitioners and to acquire the standard form of reports (BC form).
- Applicants may request a postponement of training/test/course by submitting their reasons in writing. Such a letter must reach the CIC **at least 3 working days** before the scheduled training/test/course day. If the reason is accepted by the CIC, the applicant can reschedule once for free.
- The CIC reserves all rights to amend training/test/course arrangements, including but not limited to accepting any training/test/course application and/or changing the relevant clauses in a timely manner without giving any reasons. The CIC will not accept any liability in respect of claims for expenses or other damages.
- Notice for candidates:

- (1) Candidates must show their **valid Construction Industry Safety Training Certificate (Green Card)** and **wear suitable work wear including safety shoes**; otherwise, they will not be able to attend the practical test and will be treated as absent.

- (2) Candidates who arrive late are not allowed to enter the workshop and will be treated as **absent**.
- Application:
    - (1) Applicants can enroll via the mobile application ("TTOA"). Upon approval of application, the applicants could settle the related payment via ATM / by Cheque / by bank transfer OR at 7-Eleven by presenting the barcode given in the TTOA.
    - (2) Complete the application form together with a cheque or bank draft for the course fee payable to "Construction Industry Council".
    - (3) A **photocopy** of the applicant's **HKID / CWR Card\*** and **"Construction Industry Safety Training Course Certificate" (Green Card)** must be affixed to the application form.  
*\*If the applicant does not wish to submit a copy of the HKID / CWR card, the applicant can present the original of HKID for verification in person at the Hong Kong Construction Industry Trade Testing Centre (HKCITTC), Aberdeen within 30 calendar days of application submitted.*
    - (4) Applicants must submit a copy of proof of work experience with the company's stamp and the signature of the person-in-charge, as mentioned in Part (D) above.
    - (5) Send the completed application form, a copy of supporting documents and a cheque or bank draft to the Hong Kong Construction Industry Trade Testing Centre, 38/F, COS Centre, 56 Tsun Yip Street Kwun Tong, Kowloon.
    - (6) All fees are non-refundable and non-transferrable. Applicants who want to withdraw from the test/training/course have to submit their reasons in writing to the CIC at least 3 working days before the schedule test/training/course date. An administration fee amounting to 20% of the paid fee will be charged. Special consideration will be given to applicants who request to withdraw because of prolonged injury.

1. Collection of Personal Data

The information you provide to the Construction Industry Council, its affiliates, and / or its subsidiaries, including, but not limited to, the Hong Kong Institute of Construction and Zero Carbon Building, Construction Sector Imported Labour Quarters Limited (collectively, the "CIC"), including any personal data as defined in the Personal Data (Privacy) Ordinance (Cap.486), will be used solely for purposes related to the activities of the CIC.   - 1.2. Whether or not you provide your personal data to the CIC is voluntary. However, where you are providing information for the purpose of an application, it is necessary that you supply the CIC with complete information as specified on the application form. 2. Purposes of Collection  
Your personal data will be kept confidential and may be used by the CIC for the following purposes:
