- Applicants who have completed the safety training and passed the written test and practical assessment will be issued an "Advanced Level Truss-out Scaffolder Safety Training Certificate" or an "Intermediate Level Truss-out Scaffolder Safety Training Certificate".
- Applicants who are not Hong Kong Permanent Residents, please attach the copy of valid working permit issued by the Hong Kong Immigration Department.
- Applicants who have reached the age of 65, please call Hong Kong Construction Industry Trade Testing Centre at 2100 9000 to check which trades may require the submission of medical examination reports issued by Registered Medical Practitioners and to acquire the standard form of reports (BC form).
- Applicants may request a postponement of training/test/course by submitting their reasons in writing. Such a letter must reach the CIC **at least 3 working days** before the scheduled test/course day. If the reason is accepted by the CIC, the applicant can reschedule once for free.
- The CIC reserves all rights to amend training/test/course arrangement, including but not limited to accepting any training/test/course application and/or changing the relevant clauses in a timely manner without giving any reasons. The CIC will not accept any liability in respect of claims for expenses or other damages.
- Notice for candidates:
 - (1) Candidates must show their **valid Construction Industry Safety Training Certificate (Green Card)** and **wear suitable work wear including safety shoes**; otherwise, you will not be able to attend the practical test and be treated as absent.
 - (2) Candidates who arrive late are not allowed to enter the workshop and will be treated as absent.
- Application:
 - (1) Complete the application form together with a cheque or bank draft for the fee payable to "Construction Industry Council".
 - (2) A **photocopy** of the applicant's **HKID / CWR Card ***, **"Construction Industry Safety Training Course Certificate" (Green Card)** and **"Bamboo Scaffolder Trade Test Certificate/ Intermediate Trade Test Certificate"** must be affixed on the application form.
**If the applicant does not wish to submit a copy of the HKID / CWR card, the applicant can present the original of HKID for verification in person at the Hong Kong Construction Industry Trade Testing Centre (HKCITTC), Aberdeen within 30 calendar days of application submitted.*
 - (3) Send the completed application form, a copy of supporting documents (Pt. 2 of above) and a cheque or bank draft to the Hong Kong Construction Industry Trade Testing Centre, 38/F, COS Centre, 56 Tsun Yip Street Kwun Tong, Kowloon.
 - (4) All fees are non-refundable and non-transferrable. Applicants who want to withdraw from the training/test/course have to submit their reasons in writing to the CIC at least 3 working days before the schedule test/training/course date. An administration fee amounting to 20% of the paid fee will be charged. Special consideration will be given to candidates who request to withdraw because of prolonged injury.

1. Collection of Personal Data

1.1. The information you provide to the Construction Industry Council, its affiliates, and / or its subsidiaries, including, but not limited to, the Hong Kong Institute of Construction and Zero Carbon Building, Construction Sector Imported Labour Quarters Limited (collectively, the "CIC"), including any personal data as defined in the Personal Data (Privacy) Ordinance (Cap.486), will be used solely for purposes related to the activities of the CIC. The activity and the required personal data are detailed in the application form [This Personal Information Collection Statement should be attached or printed on the application form].

1.2. Whether or not you provide your personal data to the CIC is voluntary. However, where you are providing information for the purpose of an application, it is necessary that you supply the CIC with complete information as specified on the application form. 2. Purposes of Collection

Your personal data will be kept confidential and may be used by the CIC for the following purposes:

- Performing and exercising functions and powers of the CIC under relevant legislation, rules and sub-legislation, including but not limited to the Construction Industry Council Ordinance (Cap. 587) and Construction Workers Registration Ordinance (Cap. 583);
- Registering for the trade test/course/safety training/skill assessment or any other services which you apply for on the application form and assessing your eligibility thereto related;
- Supporting all logistics and operational measures (including but not limited to administration, security, health and safety related etc.) in place in the HKCITTC, implemented at discretion of the HKCITTC for the best interest of the public and stakeholders;
